

NORTH CAROLINA

IMPORTANT DATES IN STATE HISTORY

- 1653 First settlers migrate from Virginia to Albemarle Sound.
- 1663 Area granted to eight proprietors.
- 1665 Concessions and Agreements of Albemarle Province drafted.
- 1669 Fundamental Constitutions of Carolina drafted.
- 1691 Albemarle Province recognized as the Province of North Carolina.
- 1711 Tusacarora War.
- 1712 The British Crown divides Carolina into two provinces.
- 1719 South Carolina becomes a Royal Colony.
- 1729 North Carolina becomes a Royal Colony.
- 1771 Regulator wars.
- 1780 Battle of King's Mountain.
- 1781 Battle of Guilford Courthouse.
- 1861 21 May secedes from the Union.
- 1866 More than 9,000 former slaves record their marriages in county records.
- 1868 11 June readmitted to the Union.

MARRIAGE AND DIVORCE

1669 constitution states that "no marriage shall be lawful, whatever contract and ceremony thy have used till both the parties mutually own it, before the Register of the place where they were married, and he register it, with the names of the father and the mother of each party [not widely practiced]."

According to the North Carolina State Archives, there are no known surviving Church of England parish registers for North Carolina.

1701 common-law marriages are not recognized in North Carolina.

1715 marriages are to be recorded by the Secretary of State or in a county register of deeds; marriages could be performed by clergy of the Anglican Church, the Governor, or his Councilors.

1741 law to prevent clandestine marriages requires that parties to be married must either file a marriage bond in the bride's county of residence or post banns for three weeks prior to marriage; interracial marriages are declared to be illegal (not abolished until the 1960s).

1766 Presbyterian ministers are allowed to solemnize marriages.

1851 ministers shall file a marriage return and have it recorded in the county marriage register.

1866 marriage bonds are abolished and are replaced with licenses and certificates; dower rights are reinstated.

1872 law requires parents to be named on marriage certificates.

1937 a woman receiving a divorce decree may petition the court to have her maiden name restored (these are recorded in separate registers, such as Pasquotank County Superior Court maiden names of divorced women, 1937–59 (film 0259369).

Where to Find Marriage and Divorce Records

The earliest county marriages date from 1669 to 1742. Marriage banns or bonds were required from 1741 to 1868 and are at the North Carolina State Archives in Raleigh, except for Granville and Davie counties. The county courts of pleas and quarter sessions were abolished in 1868. Marriages after this date were filed with the Register of Deeds until 1962. From 1783 until 1835, divorces were under the jurisdiction of the state legislature. From 1806 to 1835, the county

superior courts could also grant divorces. After 1835, all divorces were under the jurisdiction of the county superior courts. Many records have been deposited at the North Carolina State Archives. An index to marriage bonds, 1741–1868 (fiche 6330241), is available for purchase on microfiche. Many county records have been filmed, such as:

- Craven County Court of Pleas and Quarter Sessions marriage bonds, 1782–1865 (film 0296803 ff.), and Craven County Register of Deeds marriage licenses, 1892–1960; marriage bond abstracts, 1740–1868 (film 0288285 ff.), at the North Carolina State Archives.
- Currituck County Superior Court Negro cohabitation certificates, 1866 (film 1689140), at the North Carolina State Archives. These certificates were issued before marriage was legalized.

PROPERTY AND INHERITANCE

1663 in intestacy, a widow receives a dower of one-third of her husband's real estate owned at the time of marriage or acquired during coverture.

1715 in intestacy, a widow is to receive one-third of her husband's personal estate and one-third of her husband's real estate absolutely. In the conveyance of deeds, a married woman must be examined privately to determine if she is acting of her own free will (reconfirmed in 1749 and 1762).

1784 "the real estates of persons dying intestate should undergo a more general and equal distribution than has hitherto prevailed in this State, be it therefore Enacted . . . when any person shall die seized or possessed of, or having right, title or interest in . . . inheritance of land, or other real estate in fee simple, and such person shall die intestate, his or her estate or inheritance, shall descend in the following manner, to wit: to all the sons to be equally divided amongst them, and for want of sons, to all the daughters to be divided amongst them equally . . . as tenants in common in severalty, not as joint tenants . . . " Dower rights are abolished. If a husband is living, a wife cannot make a will without his permission.

1795 in intestacy, realty is divided among all heirs in the same degree, both sons and daughters.

1796 in intestacy, a widow may request food and necessities during the probate period from funds of the estate.

1849 "all real estate owned by a married woman at the time of marriage shall not be subject to be sold or leased by the husband for the term of his life or for a less term, except by consent of his wife." The wife's consent shall be ascertained by private examination.

1851 a married woman may be given power by will, deed, etc. to devise a will to dispose of any property.

1868 the property of any female acquired before her marriage "shall remain the sole and separate estate of such female and may not be liable for debts, obligations, or engagements of her husband."

1869 a wife's dower rights are reinstated (not abolished again until 1960).

SUFFRAGE

1920 North Carolina women receive complete suffrage by passage of the 19th Amendment to the Constitution.

One of the original Thirteen Colonies.

1785-7 state census, see Register, Alvaretta K. State Census of North Carolina, 1784-1787. 2nd ed. (Baltimore: Genealogical Publishing Co., 1978, film 0897274).

OTHER

1869 a state board of charities is established.

1885- 1953 Confederate veterans' and widows' pensions (film 0175779 ff.). Widows were eligible to file applications after 1887.

Records of widows' years' support, such as those for Pasquotank County, 1882-1960 (film 0260251). The pension and widows' support records are at the North Carolina State Archives.

News from our North Carolina Room Specialist Mark Pace

The North Carolina Room at the Richard H. Thornton Library has recently participated with the North Carolina Digitization Project to digitize and post pre-1963 school annuals online. Some 54 Granville County school yearbooks, including: Creedmoor High School, 1951; Horner Military School, 1899 to 1919; John Nichols High School, 1961; Mary Potter School, 1955, 1957 and 1958; Oxford High School, 1925 and 1953 through 1962; Shaw High School, 1952; and Stovall High School, 1939, 1952, 1955 and 1957, in possession of the Library are now online. Also included are three Vance County Annuals—Townsville, 1957 & 1958, and Dabney, 1949.

The North Carolina Digital Heritage Center is a statewide digitization and digital publishing program housed in the North Carolina at Chapel Hill. The Digital Heritage Center works with cultural heritage institutions and libraries across North Carolina to digitize and publish historic materials online. "I think this gives Granville County residents and researchers a terrific resource for community history and memory", said Nicholas Graham, Program Coordinator.

It is hoped that the publicity and awareness of the Annuals Project will encourage people to allow their yearbooks to be reproduced by local libraries, or even to be donated to such institutions. "School annuals can be a wonderful genealogical source and are sometimes the only public source available for a photo of a particular individual or even a local business", said N. C. Room Specialist, Mark Pace. "For example, someone recently wanted a good picture of the old Pine State Creamery, but couldn't locate one anywhere. Sure enough a high school annual from 1968 had a picture of the business in an advertisement in the back section of the yearbook—local businesses were often yearbook sponsors. A lot of folks don't think of an old school yearbook sitting in an attic as a historical resource—but it certainly can be" said Pace.

The Perry Memorial Library in Henderson is also a participant in the North Carolina Digital Annuals Project. Twentyfive Vance County annuals dating back to 1926, in possession of the Perry Library have been placed online.

This document was served on the Goss family for the condemnation of their property when the present day Butner was chosen as the new Army Base in southern Granville County. The document is a copy of the original (nothing changed) was donated to the North Carolina Room at the Richard Thornton Library in Oxford by Euell Gene Goss of Orange County. Although some of it is faded but still readable is the summons that these people listed had to face in 1942 with the Federal authorities. These people spent a lot of sleepless nights thinking of where they would go and what to do. The Goss family moved to Gorman in Durham County after the land was condemned for the Army base.

She was one of the first settlers upon Six Pounds Creek in No Carolina where her husband Philemon Hawkins owned a mill. The country was the a wilderness, which occasioned corn to be extremely scarce, and when the poorest of people came with their little corn to the mill, instead of taking toal, she would add to their morcell and have it ground into meal gratis. She was universally kind to the poor, the Great creator of us all blessed her with a great share of health and wealth and she lived to be 73 years of age.

Philemon Hawkins father of Philemon Hawkins of Pleasant Hill was born in Virginia, he moved to the mouth of Six Pound Creek in No Carolina, was one of the settlers there he was extremely active industrious man and uncommonly good husband and father, one of the best providers for a family. The creator blessed him with a great share of health and wealth and he lived to be nearly 80 years of age, he departed this life 10th day of September A.D. 1801.

Col. Benjamin Hawkins Agent for the Creek Indians departed this life the 6th of June at 8 o'clock in the evening 1818, in the 62nd year of his age, he has served as a Publick Character in various departments and always discharged the Trust faithfully for 36 - years - a worthy Honest man.

George Washington Hawkins departed this life the 26 day of March 1816. Capt Philemon Hawkins departed this life the 22nd day of March 1817 - Two of as Trusty sons as I ever raised.
